NW Montana MARCH 20, 2015 Man pleads not guilty to school threats

A Kalispell man pleaded not guilty Thursday to charges that he threatened violence against Jews and attacks on a local school.

David Joseph Lenio, 28, has been charged with intimidation and criminal defamation, both felonies.

Unlike his initial court appearance, in which he disrupted the court with claims of conspiracies, Thursday's proceeding was quick and quiet.

Lenio asked for a quick clarification after District Judge Heidi J. Ulbricht read his rights. Then his attorney, Brent Getty, entered a plea of not guilty.

Police arrested Lenio on Feb. 16 after threatening online

messages passed through law enforcement from coast to coast. It started when Lenio had a run-in with an anti-gunviolence activist over the Internet.

The activist was Jonathan Hutson, the chief communications officer for the Brady Campaign and Center to Prevent Gun Violence.

The organization is based in Washington, D.C. After he exchanged messages with Lenio online, Hutson looked into Lenio's archives and found years of inflammatory comments.

"His current and former social media accounts contain a trove of information about his movements and motives," Hutson said.

On a hunch, he contacted law enforcement in Oregon, which tracked Lenio to the Flathead Valley. Law officers arrested Lenio as he was leaving Whitefish Mountain Resort.

In their investigation, police found two rifles at his home and a handgun in his car. They also learned that Lenio had moved a rifle from a storage unit to his residence the day before.

Hutson has dug into Lenio's archives to learn about the man who would make such heinous threats. He found that Lenio graduated from high school in Michigan and lived in Colorado before moving to Kalispell in 2014

All along, he posted videos and messages online about various conspiracy theories, perceived institutional problems and outright threats.

On Dec. 30, Lenio Tweeted that he wanted to go on a killing spree at a Kalispell elementary school, referring

Whitefish celebrates new high school

In 2009, the Whitefish School Board set a goal to be in a new high school within four years. The goal followed on the heels of two failed bond requests to renovate the high school in 2003 and 2008.

Although it took more time to achieve the goal, on Thursday it was mission accomplished.

In the new high school gym, Whitefish High School Superintendent Kate Orozco welcomed an audience to the dedication of the new high school, which cost \$23 million to build. The process began in 2012 with passage of a \$14 million bond request.

"After five years of hard work, and design and discussion, and debate and dreaming we are standing here now thanks to all of you and many others," Orozco said. "We are standing in a beautiful state-of-the-art school that is truly worthy of the promise of our kids.'

To commemorate the occasion, Montana Governor Steve Bullock gave some remarks, beginning with his ties to Whitefish — the town where his wife was born and where her father had been a teacher at the high school.

Bullock spoke to the importance not only of the teachers inside the building to education, but the building itself.

'Our children cannot learn as effectively if they don't have an effective place to learn," Bullock said. "You have a wonderfully effective place to learn. As students prepare for jobs of the future they now have a building that will also keep pace.

City of Whitefish Mayor John Muhlfeld also spoke about the city's involvement in supporting the high school construction project, by allocating \$2.5 million from the city's tax increment finance district to move the project forward in 2012.

"When the TIF district was originally

set up in 1987 the city agreed to support the school district." Muhlfeld said. "As a community we did this because we recognized then and we recognize now the importance education plays in supporting and growing our economy in Whitefish.'

WHITEFISH HIGH SCHOOL Principal Kerry Drown described the progress of the construction project as going "from idea, to paper, to dirt, to concrete, studs and steel to the incredible building called

Whitefish High School." Drown used the moment to recognize and applaud the work of numerous supporters, donors, school board members and employees.

"On behalf of our faculty, staff and student body, I'm here to express gratitude and thanks to the many, many people who are part of the Whitefish High School building project," Drown said.

Project manager Dow Powell and contrac-tor Loren Cantrell of Langlas and Associates were among the people thanked.

Cantrell recalled his early involvement in the project.

"I heard several times from those already involved with the project, 'Are you sure you know what you're getting into? Building in Whitefish is different," Cantrell said, his comment met with chuckles from the audience. "Each time I heard that I smiled politely and thought, 'We've built a lot of schools around Montana and in small communities, how different can it really be?"

Cantrell said in the months following he came to appreciate — in a positive way — just how different it was.

"Never before had I been involved in a project where the city stepped forward as they have. Where private organizations such as the Iron Horse Foundation and private donors stepped forward and said, 'We want to make this school even better then it already is.""

to the tragic 2012 mass shootings at Sandy Hook Elementary School in Newtown, Conn.

"He was indicating that he wanted to use Sandy Hook as a template for his own actions," Hutson said. "And then after Tweeting his threats, he went to his storage locker to retrieve his rifle."

That escalated the concern for local law enforcement, and they arrested Lenio on President's Day, when most schools were not in session

Hutson said that he acted more as a concerned father than as a spokesman for the Brady Campaign.

As the case moves forward in court, he said that he would be paying close attention.

It was Hutson's concern that alerted police to a serious threat.

"This is a case of 'If you see something, say something," he said. "We can all play a role in making this the safer America we all want and deserve.'

Lenio's next court appearance will be an omnibus hearing on May 6. A trial is tentatively scheduled for July 6.


